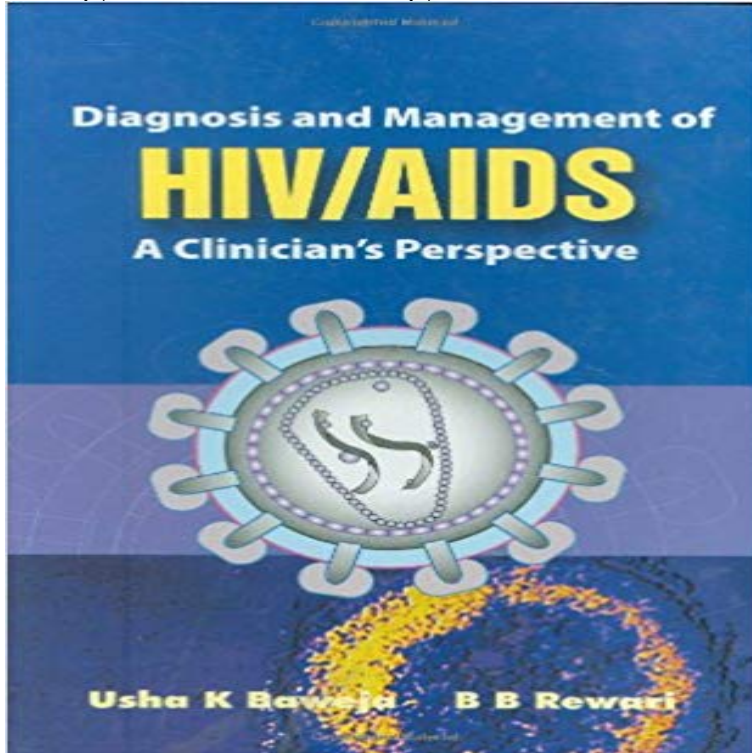


## Diagnosis and Management of HIV/AIDS: A Clinicians Perspective
